### 4. FIRST AID MEASURES

**First aid measures****General advice**

Immediate medical attention is required.

**Skin Contact**

Immediate medical attention is required. Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes.

**Eye contact**

Do not rub affected area. Immediate medical attention is required. Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing.

**Inhalation**

Remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Call a physician or poison control center immediately.

**Ingestion**

Drink plenty of water. Immediate medical attention is required. Remove from exposure, lie down. Clean mouth with water and drink afterwards plenty of water. Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Call a physician or poison control center immediately.

**Note to physicians** Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated. Do not give chemical antidotes. Asphyxia from glottal edema may occur. Marked decrease in blood pressure may occur with moist rales, frothy sputum, and high pulse pressure. Treat symptomatically.

## 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media**
